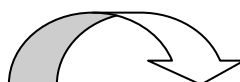

PARENT'S AGREEMENT
PLEASE READ CAREFULLY BEFORE SIGNING

1. We give permission for our child to take part in all school activities, including sports and school-sponsored trips away from the school premises, and absolve the school from liability to us or our child because of any injury to our child at school or during any school activity.
2. We agree to uphold and support the high academic standards of COMMUNITY BAPTIST CHRISTIAN SCHOOLS by providing a place at home for our child to study and by giving our child encouragement in the completion of homework and assignments.
3. We recognize that for our child to make good progress in his work, it is essential that he have confidence in his teacher and school. Therefore, we will do all in our power to see that our child respects and obeys the school staff and rules. We agree that if our child should become involved in any difficulty in the school, we will in no case complain to any other parent but with prayerful, Christian spirit will register only necessary complaints with the teacher or principal.
4. We consider it a real privilege to have the opportunity to send our child to COMMUNITY BAPTIST CHRISTIAN SCHOOLS and shall endeavor to support and uphold the principles, practices, and educational policies of the school. While recognizing the potential for differing Christian convictions on some issues, in an effort to avoid confusing our child we will attempt to maintain a home life supportive of the administration's convictions and Biblical standards. In an effort to build up the spiritual life of our young person, we agree to abstain from worldly entertainments in our home, specifically, but not limited to, rock music, ungodly videos and television programs, etc.
5. We realize that a Christian school is not a substitute for the training, fellowship, and discipline of a local Bible believing church. Therefore, we agree to have our child in regular attendance in Sunday School and church.
6. We understand that the tuition payments are due on or before the fifth day of each month. Payments may begin in June or August but must be completed by May 5; any account not paid by the fifth of each month will be assessed a \$10.00 late fee (per month). Any child whose account is 60 days overdue could be subject to dismissal from the school. No school records will be released until bills are paid.
7. We believe discipline begins in the home, but we grant permission to the school authorities to discipline our child and to allow whatever disciplinary measures are necessary at school. (CBCS does not administer corporal punishment.) We further agree to cooperate and discipline our child in the home. We understand that any student is subject to review for dismissal at any time. If this is done, and our child is withdrawn, we realize that the current month's charges are due and payable and will not be refunded.
8. We have read the dress code standards and agree to see to it that our child adheres to them. We have read the statement of faith and give our permission to the school to teach this doctrine to our child. (See CBCS Guidelines Booklet.)
9. We give the school permission to use a photograph that contains an image of our child in its publications, yearbook or website; or we will contact the school if we do NOT grant permission. (If you as a parent do not want an image of your child posted on the school's website, for example, simply contact the school and your child will be placed on a "no website photo" list.)
